CORRESPONDENCE:


NEW BUSINESS: A Town Hall meeting will be held to create a board to decide where the ARPA funds will be best suited for the township.

The Water and Sewer handbook will be sent to the township attorney for review.


PUBLIC COMMENT: James Minor addressed the board on the upcoming election and the county millage proposal along with an update on Develop losco.
